



**NON-RESIDENT STUDENT TUITION AGREEMENT
2026-2027 School Year**

Per Ohio Revised Code 3313.64(F), a parent may enroll their child into a school district tuition free while waiting for the completion of a newly built home in the district or waiting to close on a home they have in contract to purchase. Tuition-free attendance will not exceed 90 calendar days. A parent who decides to enroll their child into Hilliard Schools in this situation must complete a tuition agreement and provide a check equal to 30 days of tuition.

Acceptance

Parent requests that the following student(s) attend the Hilliard City School District free of tuition obligation for no more than 90 calendar days while waiting for the completion of a newly built home or waiting to close on a home the parent has in contract.

Tuition - Deposit

If the construction of a new home is not complete or the parent has not closed on the home within 90 calendar days, tuition will be required for school attendance. The 2026-27 tuition rate is determined by the Ohio Department of Education and is as follows:

Regular full day student: \$12,075.00 / 176 = Daily Rate: \$68.61

A deposit equal to 30 days of tuition (per child) is collected at the time of enrollment. Payment will be in the form of a check, payable to the Treasurer of the Hilliard City School District (\$68.61 x 30 days):

Regular full day student: \$2,058.30 (including full day kindergarten students)

Non-Resident Student Tuition Agreement

The deposit will be held uncashed by the Treasurer for 90 calendar days. If residency is established during the 90-day period, the uncashed check will be returned to the parent. If residency does not occur during the 90-days, the check will be cashed and credited toward tuition (see below).

In the event the parent/guardian does not complete the purchase or does not become a Hilliard City School District resident within the 90 days, the parent agrees to make monthly tuition payments (\$68.61 per day), per child, as follows:

November 1-30 (16 days): \$1,097.76
December 1-31 (15 days): \$1,029.15
January 1-31 (19 days): \$1,303.59
February 1-28 (18 days): \$1,234.98

March 1-31 (19 days): \$1,234.98
April 1-30 (19 days): \$1,234.98
May 1-30 (19 days): \$1,234.98

Parent further agrees to make tuition payments prior to the first day of each month. When the parent becomes a permanent legal resident in the district, the prorated portion of the month's tuition payment shall be refunded to the parent. *In the event payment is not received prior to the first day of the month, the student will not be permitted to attend school until payment for the month has been received by the Treasurer.*

Transportation

Transportation is not provided for non-resident tuition students.

Compliance

Tuition students shall comply with all school policies and regulations in order to continue enrollment in the Hilliard City School District.
