## Josie Tabaka

Hello. My name is Josie Tabaka. I'm a parent of a student at Ridgewood Elementary School. I live in Ridgewood Estates, approximately three-quarters of a mile from the school. This past summer, Norwich Township changed the bridge walkway area to a no-parking zone. This was done under the auspices of making it safer for student walkers. It has made the area much less safe. The chaos of people dropping students off has now been extended to a much broader area of Ridgewood Estates.

I am here because many parents brought their concerns to the Norwich Township Trustees, who made the change. They told us that this is the Hilliard Board of Education's responsibility to fix.

I am here to notify you that this area is unsafe for our children. There is no way to stop and assist a child who needs help walking to or from school. It is unrealistic to expect a young child such as a kindergartner to walk in a neighborhood without sidewalks on their own. Additionally, due to the conditions of the drop-off area at Ridgewood on Dublin Road, many parents from other neighborhoods are using the walk or drop-off zone in Ridgewood Estates, which contributes to congestion in our neighborhood.

There is a resident who lives at the corner of Cameron and Darbyshire, who has installed multiple cameras at the drop-off zone and has created a website with film of our children walking to and from school and parents in the drop-off zone. I feel incredibly uncomfortable trusting this man around my child.

I look forward to your solution.

#### Jim Tarantine

Good evening everybody. My name is Jim Tarantine. I'm the proud son of a retired public school superintendent and elementary school teacher. I was also the superintendent's son at Johnson High

School. I know firsthand what it feels like when a community doesn't support their school system, their teachers, their administrators, and most importantly, their students.

But I'm not here to talk about that tonight. And I'm not here to talk about how proud I am of my eleventh-grade daughter, Aria. I'm here on a very positive note to proudly talk about my son, James Tarantine, Hilliard Davidson's class of 2024. He was an honor student, varsity football and hockey captain, Buckeye Boys State representative, Ceramics Governor's Cup finalist, and now a freshman, or plebe, at the United States Military Academy at West Point.

Specifically, though, I want to thank three people in the district. First, I want to thank Mr. John Horn, James' ceramics teacher at Hilliard Davidson. When you run through James' resume—hockey player, football player, West Point cadet—it doesn't scream out arts. But Mr. Horn helped James find his passion for ceramics. With all the accolades that James got last year, my favorite moments were the ones at the Governor's Cup show for the arts and the art show at Davidson. To see James laughing and smiling with kids that on paper were very different from him made me truly appreciate what Mr. Horn and Hilliard Davidson do.

If you look at the pictures of Mr. Horn's students, you'll see jocks, theater kids, and bandies, a diverse group of all united in their passion. Thank you, Mr. Horn, publicly. As you know, arts are one of the programs that can be at risk when a community does not support their schools.

Second, I want to thank Vice Principal Matt Faska. Mr. Faska was a voice of encouragement, advice, and really helped James navigate through his senior year. He's honest, direct, and truly cares about our Davidson students' dreams in high school and beyond. James wanted to record a video, but at West Point, it's kind of frowned upon since he's a representative of the U.S. Army now. Thank you, Mr. Faska. As you know, schools can be at risk when a community doesn't support their school system.

Last but certainly not least, I want to thank Tom Woodford. I can say this with 100 percent certainty, James would not be at West Point if it wasn't for him. Two years ago, Mr. Woodford gave James a checklist. Here's what it takes. Here's what you gotta do. Here's the bar you're setting for yourself. You gotta have a plan B. You gotta have a plan C. From that point forward, Coach Woodford was always available. He helped James with communication, had advice each step of the way, and gave direct feedback when James took a different turn. He was and is a mentor.

When James got into West Point, I called Coach Woodford and I told my wife I think Tom's more excited than we are. Thank you, Coach. Oh, and to keep with the theme as earlier, college counselors and other key administration roles that Hilliard provides our awesome students could be at risk when the community doesn't support their schools.

F2 The Board of Education approved the following resolution:

META Cooperative Advertising and Receiving Bids for School Bus Chassis and Bodies

WHEREAS, the Hilliard City Schools Board of Education wishes to authorize the Chief Operating Officer to advertise, receive bids, and purchase up to ten (10) 78-passenger conventional school bus chassis and bodies.

THEREFORE, BE IT RESOLVED the Hilliard City Schools Board of Education wishes to participate and authorize the META Solutions (META) to advertise and receive bids on said Board's behalf as per the specifications submitted for the cooperative purchase of up to ten (10) 78-passenger conventional school bus chassis.

#### Discussion:

Mr. Dudgeon explained that this resolution allows Meta Solutions to negotiate pricing on behalf of the district as part of the larger consortium of participating districts. It's non-binding, and we're not obligated to follow through with a purchase.

F3 The Board of Education approved the following resolution:

The Superintendent recommends Fanning Howey as the most qualified firm to serve as the design professional and to provide the master planning, design, and related construction administration services for the Capital Improvements Project – Phase I (the "Project").

## Rationale:

- 1. The Board requires a design professional to provide the master planning, design, and related construction administration services for the Project.
- Sections 153.65 through .71 of the Ohio Revised Code prescribes a qualifications-based selection process, which is required to be followed by public entities when design professional services are needed.
- 3. In accordance with the statutory process, the Superintendent publically advertised and issued a request for qualifications for design professional services and evaluated the statements of qualifications submitted by the professional design firms. The District received several statements of qualification and ranked them in accordance with the criteria outlined in the request for qualifications.
- 4. Following this evaluation, the District identified Fanning Howey to be the most qualified design firm to provide the required design professional services.
- 5. The Superintendent recommends that the Board select Fanning Howey as the firm most qualified to perform the design and related construction administration services for the Project.

The Board of Education resolves as follows:

The Board selects Fanning Howey as the firm most qualified to perform the master planning, design, and related construction administration services for the Project and authorizes the Superintendent, working with other District administrators and legal counsel, to solicit a pricing proposal from Fanning Howey and negotiate an agreement for the Project. The agreement will be brought to the Board for approval at a later date.

#### Discussion:

Mr. Perry asked for an overview. Mr. Stewart said the district has had a decades-long relationship with Fanning & Howey. As we look towards the successful passage of Issue 39 and the related construction projects that would come along with that, we need to appoint a firm to serve in those roles. Six firms submitted the request for qualifications. Those qualifications were scored on a rubric, and Fanning and Howey was the firm that was selected.

Following the vote, Mr. Stewart pointed out two of our contacts from Fanning and Howey. Unfortunately, I can't see them, but Jen Fuller and Brandon Binnicker are both here. I just want to say congratulations and look forward to a lot more years of a great working relationship.
